B. PRESIDENT'S REPORT

- 1. Introductions:
- a. Tom Moore thanked all members for attending the first Zoom AGM; members of the Board and Committee Chairs were introduced and thanked individually for their work over the past year.
- 2. Summary of Fiscal 2019
- a. a profitable year with the success of the St. Peters Harbour Lighthouse Dinner held at Holy Cow on August 19th, as well as the first sales of SPHLS t shirts and hoodies.
- b. an active year within the SPHLS and the greater community including the first Lighthouse Illumination Party and participation in the River Run Parade.
- c. the promising start up of various heritage activities.
- d. however the late winter brought a new reality to the SPHLS: how to deal with Covid 19. Early Board meetings were held in April and May to contemplate adjustments to the 2020 schedule; members were invited to contribute a food drive for those in need, as sponsored by the Morell Co-op and Lions Club.
- 3. Outlook for Fiscal 2020
- a. by mid August, all SPHLS activities requiring group attendance were cancelled due to Covid 19.
- b. as originally intended, there will not be another major fundraiser until 2021.
- c. financing for 2020 will consist of membership fees and donations, as well as further retail sales.
- d. 2 model lighthouse donation boxes are being made for use at the Morell Welcome Centre and St. Peters Landing. Another "mail box" is being made for a post location in the path to the beach at the lighthouse; all donation boxes are being contributed by Joe Dunphy Cabinets in Morell.
- e. the next painting of the lighthouse will be in the late Spring of 2021 at an approximate cost of \$5500, by Gil O'Meara of East Royalty. Bill Connally has withdrawn from the work.

B. TREASURER'S REPORT

- a. Chris Hutt reviewed the Financial Statements of May 31, 2020 (2019 fiscal year ending May 31st 2020), as prepared by MRSB Consultants.
- b. As noted on page 2, Net Assets of the SPHLS as of May 31 are \$ 22,900.; these assets are carried in three separate accounts: a current account for annual expenses as well as lighthouse painting every 5 years, a building account for construction projects, and a flex account for special projects including fundraising events.

E. BOARD MEETING OF SEPTEMBER 24TH: FOLLOW UP TO THE AGM

The Board held it's final meeting of the season by Zoom on Sept.24th, 2020. The following are highlights of that meeting that bear interest to the AGM.

- 1. 2021 SPHLS Family Golf Tournament: The Board of Directors selected a 9 hole family golf tournament to be held at the Peaks Tee golf establishment on a Saturday in August of 2021. An indoor / outdoor luncheon and various fundraising events will be included.
- b. The event is seen as the next in a series of successful and fun filled SPHLS fundraising innovations. In particular, it is manageable for Covid regulations that may be required at that time.
- c. Event organizers will provide further details during the fall of 2020 and spring of 2021.
- 2. 2021 Officers of the Board
- a. the Board of Directors confirmed its Executive for 2021, as required at the first meeting following the AGM by the Articles of Incorporation.
- b. resignation of Tom Moore as President: Tom Moore announced he will be stepping down as President as of September 24th, for reasons of health. Tom will continue as a Director at Large and assist in the transition to a new President for the SPHLS.
- c. Steering Committee: Bill Morton, Chris Hutt and Craig Ono will return as Vice President, Treasurer and Secretary respectively. They will form a Steering Committee to run the affairs and meetings of the SPHLS until a new President is found. They will chair meetings in rotation, the first being Bill Morton.
- d. Search Committee: Katie Sheehan will join BM, CH and CO to form a search Committee for a new President. Candidates may include members of the Search Committee, other members of the Board or SPHLS Membership, as well as non members from the community who may wish to join the organization. The goal is for a new President to be in place for May 31, 2021. Ratification by the membership, if required, will be held by vote at the next AGM.
